Village Sign Repair – Update

We know that people are wondering what has happened to the village sign so this edition includes an update.

Work is progressing; however, it is taking longer than expected due to the wet weather and length of time taken for the wood to dry out, allowing for the cast to be made.

The new sign will be a fibreglass structure which will counter the difficulties we have experienced with the rotten wood.

The new sign is expected to arrive in time for the Jubilee weekend and we cannot wait to have it back in its rightful place.
